Academic Buildings Construction, Renovation and Maintenance \$823,000
 Claflin University will use HEEEP funds to construct and renovate all academic buildings. The institution is in the process of two new constructions for academic buildings, and costs associated with planning and development will be used in this year's funding. The institution will follow CDC guidelines to ensure proper workplace measures are in place to reduce exposure. We conduct maintenance and repair activities to reduce risk and safety concerns for students, faculty, and staff. Maintenance and repair will include mechanical heating and ventilation (HVAC) and irrigation system upgrades and repairs. Repair of plumbing and electrical systems. All upgrades will be done to include measures for energy efficiency and energy-smart solutions.

Claflin University Innovation Center TITAN \$350,000
 Claflin University AmeriCorp VISTA Program \$20,000
 Student Development will provide leadership development for five AmeriCorps VISTA students in tutoring, career development and enrollment. The VISTAs will assess our current programs for student academic success and expand and improve our support services programs.
