Transfer Mobility of Credits

Keep in mind the following(ATCD):

1. **A**dmⁱssibility: Refers to the extent to which military experience credit courses determine a transfer student's admission to a university and, when applicable, admission to a specific program within a university.
2. **T**ransferability and **D**egree **A**pplicability-. Refers to the conditions under which a college/university accepts military experience credit courses for inclusion in the student's record.
 - **THINGS TO WORK ON:** Take a look at your military equivalences Work with colleges to consider more direct subject matter equivalencies
3. **C**ourse Equivalency and **T**ransferability: Refers to the process of equating a transfer student's military experience credit courses, both in hours and content, to a university's coursework.
 - **THINGS TO WORK ON:** Take a look at transfer equivalences your institution has already established for military credit within current articulation agreements (if any)
4. **D**egree **A**pplicability: Applicability of credit toward a degree refers to the prerogative of an academic authority to count specific military experience credit courses toward the fulfillment of a student's degree requirements
