- Medical University of SC to proceed with construction for the replacement of the roof of the Clinical Sciences Building. (<u>Click Here</u>)
- Clemson University to finalize the acquisition of property (Emerging Technology Building) by acquiring a 49,380 square foot office warehouse facility on 6.94 acres of land at the Clemson Research Park in Anderson. (Click Here)

- Clemson University for 24,000 square feet of space in Greenville for the Clemson Computing and Information Technology staff. (<u>Click Here</u>)
