HIGHLIGHTS OF CHE MEETING JANUARY 8, 2015

The following information is intended to be a brief summary of Commission actions and should not be considered as any form of minutes for the referenced meeting. Blue underlined text is hyperlinked.

Commissioners recognized former College of Charleston President George Benson and thanked him for his service from February 2007 through June 2014 as the 21st president. Dr. Benson was presented with a framed resolution in recognition of his many accomplishments.

Dr. Richard Sutton, Executive Director, delivered his inaugural address on the state of the system of higher education in SC. His remarks are available <u>HERE</u>

Panel discussion on the Higher Education Efficiency, Effectiveness and Accountability review Study Committee: In the FY 2014-15 Appropriations Act, provisions and funding were included to initiate review of SC's universities and the appointment of a 13-member committee to oversee the process. The committee members include three appointed by CHE representing a university trustee, president, and finance officer. CHE's appointees The Honorable David Wilkins, Chair of Clemson University Board of Trustees, President Fred Carter of Francis Marion University, and Mr. Ed Walton, USC Senior Vice President for Administration and Chief Operating Officer joined Commissioners for a discussion of the Study Committee and higher education. The members commented on meetings held during the fall, noting the committee's realization of the need to extend the February deadline for the review. They reported that the committee has discussed consideration of the engagement of a third party to assist with the work and has determined that the work will benefit from a proposed higher education summit designed as a working meeting to share across the system and assist in informing needs of an outside review that may be conducted. The members noted that the committee conducted a comprehensive survey of the higher education institutions to determine efficiency studies conducted to date. They each stressed the importance of taking a systemic, systemwide approach rather than focusing on individual institutions. Commissioners engaged the panel in a discussion about higher education, its public perception, the relationship between higher education and future workforce needs, and the importance of engaging the business community. CHE offered its support and assistance with respect to the summit as the committee discussion and activity evolve. The interim capital project requests approved by CHE are next considered by JBRC. CHE staff presented for information, a report on capital projects and leases process by CHE staff in November and December 2014
