# HIGHLIGHTS OF CHE MEETING NOVEMBER 5, 2015

The Commission held its November meeting on the campus of S.C. State University. Interim President W. Franklin Evans welcomed Commission to the campus. Following CHE's business meeting, CHE members and staff took part in a tour of the campus.

#### CHE approved the following items:

- New Academic Program requests including: 1) at The Citadel, four programs - M.A. in Intelligence and Security Studies, M.S. in Civil Engineering, M.S. in Electrical Engineering, and M.S. in Mechanical Engineering; 2) at Clemson University, the B.A. and B.S. in Justice Studies; 3) at Coastal Carolina University, a B.A. in Art History, and 4) at Winthrop University, the Ed.S. in Educational Leadership
- Initial Application for Licensure for <u>Augusta University</u>, <u>Augusta</u>, <u>Georgia to offer in Aiken, SC, the M.Ed. in Curriculum and Instruction</u>
- Interim capital project for <u>Horry-Georgetown Technical College</u> to acquire from the S.C. Department of Employment and Workforce 2.2 acres of vacant land that borders the College's Conway Campus
