COMMISSIONER UPDATES, MAY 2016

CHE did not approve the following agenda item

At the request of the Committee on Finance & Facilities Chair Hood Temple, the <u>Coastal Carolina Brooks</u> <u>Stadium Expansion Project</u> was removed from CHE's consent agenda as the committee had deferred the proposal to the full Commission for consideration without a recommendation. After 3¹/₂ hours of discussion among Commissioners and university representatives, the proposal was <u>not approved</u> by a vote of 9 - 4. The following statement on the project was issued following the meeting: "The Commission supports Coastal Carolina University's desire to move to the Sunbelt Conference. However, the Commission continues to have concerns regarding the most recently proposed funding model and its long-term potential to significantly impact student costs and to negatively affect the general academic operations of the university. The lack of private donations for this non-academic capital initiative and failure to provide convincing cost and revenue projections were key among the concerns raised by Commissioners."
