Commissioner Dalton noted that while the Committee on Finance and Facilities recommended the seven proposed capital projects and one requested lease approval at its committee meeting on May 5, in light of the uncertainty caused by Covid-19 surrounding state and institutional finances, he was presenting a motion to recommit the seven capital projects and one lease request to the Committee on Finance and Facilities for review at a later date. The motion was seconded by Commissioner Batson and passed unanimously. Commissioner Batson commented that colleges would not be required to go through the vetting process again.

Commissioner Dalton presented the item 6.04.C for information purposes. Mr. Bryce Wilson, the agency's Chief Financial Officer, briefly overviewed for the Commission item 6.04.D. Report on FY 2019-20 Third Quarter Financial Statements. There was brief discussion of the agency's quarterly budget utilization.

#### 8. Other Business

Commissioner Smith initiated a discussion of the re-opening of college and university campuses for the Fall 2020 semester.

Commissioner Smith motioned for the Commission to issue a strong statement of support for each college and university, due to their educational contribution and strong economic role, to open campuses to students in the fall, in alignment with the Governor's executive orders and with all due considerations to safety.

Commissioner Brown expressed some concern and suggested amending the motion to read: to support colleges and universities *in their efforts* to re-open in the fall. Commissioner Horne agreed with Commissioner Brown. Commissioner Seckinger suggested the Governor's opinion be sought.

Chair Hayes suggested the motion be amended to direct staff to craft a statement pursuant to Commissioner Smith's motion as amended by Commissioner Brown. Commissioner Dolny agreed.

Commissioner Battle recommended the motion include language to clarify the Commission's conjunction with the Governor's plan.

Commissioner Smith's motion, as amended first by Commissioner Brown, then by Chair Hayes, and finally by Commissioner Battle, received a second and was passed.

#### 9. Public Comment

There were no comments from the public.

#### 10. End of Business Meeting

Commissioner Satcher motioned that the Commission recognize and express appreciation for the state's three research institutions and their collaboration with DHEC to confront COVID-19 issues, specifically in the fields of clinical research and testing. Seconded by Commissioner Dolny, the motion passed unanimously

With a motion, second, and unanimous vote, Chair Hayes adjourned the meeting at 3:06 p.m.
