### 1. Welcome

Dr. Berry welcomed everyone to the meeting at 10:00 a.m.

### 2. Introductions, Quorum, and Freedom of Information Act

Dr. Price announced attendance, established quorum, and confirmed the meeting was being held in accordance with the Freedom of Information Act.

# 3. Approval of Agenda

Dr. Berry called for a motion to approve the meeting agenda. A motion was made and seconded. Dr. Berry called for a vote. **Motion passed unopposed.** 

### 4. Approval of Minutes

Dr. Berry called for a motion to approve the September 26, 2024 meeting minutes. A motion was made and seconded. Dr. Berry called for a vote. **Motion passed unopposed**.

### 5. Academic Common Market Program and Regional Contract Program

Ms. Pitts gave a summary of the annual reports regarding the Academic Common Market Program (ACM) and the Regional Contract Program (RCP) for the 2023-2024 academic year and provided a list of undergraduate programs no longer being offered out-of-state to South Carolina residents at in-state tuition rates. Ms. Pitts encouraged the institutions to consider adding some of these programs or concentrations to their catalogs to encourage students to stay in South Carolina. Ms. Pitts explained the Optometry RCP will continue for South Carolina students attending out-of-state institutions but waivers for those currently attending out-of-state veterinary programs will only be honored through 2029 with Clemson University's Doctorate of Veterinary Medicine program expected to open in Fall 2026. Discussion was had regarding the possible reasons for states no longer offering these programs and it was requested Ms. Pitts provide the number of South Carolina students currently participating in each of the closing programs.

### 6. New Program Proposals

- a. Winthrop University, Doctor of Education in Leadership and Innovation; and
- b. <u>Winthrop University, Mission Statement Change</u> The institution moved approval of the program (Item 6.a.), combined with its proposed Mission Statement change (Item 6.b.), which was seconded. Both were presented. The institution acknowledged receipt of a list of concerns and questions from the University of South Carolina (USC) and assured the comparison table in its proposal would be updated to reflect USC's concern of overlap of the program's intended audience. Further, the institution explained it intends to focus on the immediate area around Rock Hill with likely only 10-15 students per cohort, while USC graduates 75 or more a year. The institution will also offer in-state tuition to graduate students residing in Mecklenburg and surrounding counties. USC expressed appreciation for the acknowledgement but remains very concerned with the number of Ed.D. programs in the state, especially this one as it will be offered 100% online, as is USC's Ed.D. program. The College of Charleston expressed support of the program. With no further discussion, Dr. Berry called for a vote to recommend the program and the Mission Statement change to CAAL. With no opposition, and abstention from USC Columbia and USC Beaufort, the motion passed.
- c. <u>Medical University of South Carolina, Master of Science in Pathologists' Assistant Studies</u> The institution moved approval of the program, which was seconded. The program was presented and the floor opened to questions. With no further discussion, Dr. Berry called for a vote to recommend the program to CAAL. **Motion passed unopposed.**

#### d. Winthrop University, Bachelor of Science in Artificial Intelligence

The institution moved approval of the program, which was seconded. The program was presented and the floor opened to questions. USC Beaufort expressed support of the program. With no further discussion, Dr. Berry called for a vote to recommend the program to CAAL. **Motion passed unopposed**.

### 7. New Center Proposal

a. <u>University of South Carolina Columbia, Carolina Institute for Battery Innovation</u> The institution moved approval of the center, which was seconded. The center was presented and the floor opened to questions. USC Beaufort expressed support of the center. The institution was asked if it currently has or plans to have any academic programs associated with the center, with the response there may be several engineering, supply chain, and logistics programs in the future. With no further discussion, Dr. Berry called for a vote to recommend the center to CAAL. **Motion passed unopposed**.

# 8. Program Modification Proposal

- a. <u>University of South Carolina Beaufort, Bachelor of Science in Nursing, pre-licensure track</u> The institution moved approval of the program modification, which was seconded. The program modification was presented and the floor opened to questions. Discussion was had regarding when enrollment would begin and what, if anything, was needed from Beaufort Memorial Hospital. It was noted the proposal incorrectly lists Lander University as a private institution, which the institution confirmed will be corrected. With no further discussion, Dr. Berry called for a vote to approve the program modification. **Motion passed unopposed**.
- b. <u>University of South Carolina Salkehatchie, Associate of Arts and Associate of Science in</u> <u>General Liberal Arts and Sciences</u>; and
- c. <u>University of South Carolina Union, Associate of Arts and Associate of Science in General Liberal Arts and Sciences</u> The institution moved approval of both program modifications, which was seconded. The program modifications were presented and the floor opened to questions. With no further discussion, Dr. Berry called for a vote to approve the program modification for Item 8.b. Motion passed unopposed. Dr. Berry called for a vote to approve the program modification

- b. New Math Standards Survey

Dr. Berry advised the South Carolina Department of Education (DOE) has approved new math standards, which will go into effect in 2025. CHE's college preparatory course prerequisite requirements were approved in 2015. A survey will be provided to the institutions to offer feedback regarding admissions policies in relation to the new DOE standards. Questions were raised regarding the two (2) pathways for math, to which Dr. Berry stated she will share the fact sheet from the DOE, as well as any additional information obtained going forward.

- c. <u>AY 2023-2024 Approved Academic Programs Report</u> Dr. Berry stated a first draft of the report will be provided to the institutions for review and revision, with the intent to present to CAAL at its November 21, 2024 meeting.
- d. <u>AY 2023-2024 Academic Common Market Annual Report and AY 2023-2024 Regional</u> <u>Contract Program Annual Report</u> Dr. Berry stated both reports will be presented to CAAL at its November 21, 2024 meeting.
- e. Proposal Revisions

Dr. Berry expressed appreciation to the institutions for their responsiveness to CHE staff's requests for clarification and/or revisions to academic proposals.

f. <u>Agenda Proposals</u>

Dr. Berry invited the institutions to provide suggestions for ACAP agenda items which may benefit the group.
