### **Background Information**

The primary mission of the University of South Carolina is the education of the state's diverse citizens through teaching, research, creative activity, and service. Founded in 1801, the USC system is the largest university in the state, serving more than 50,000 students from its flagship Columbia campus, three comprehensive campuses (Aiken, Beaufort, and Upstate), and four regional campuses (Lancaster, Salkehatchie, Sumter, and Union).

The University of South Carolina Sumter, a regional campus of the University of South Carolina, has as its mission to provide higher education and intellectual leadership to residents in its area. Its mission and vision statements were approved by the University's Board of Trustees in October 2023: <a href="https://www.sc.edu/about/system">https://www.sc.edu/about/system</a> and campuses/sumter/about/mission and vision/

To better serve constituents in the South Carolina Midlands, USC Sumter seeks the establishment of an educational site in at Hammond School in Columbia, SC. The physical address of the site is 854 Galway Ln, Columbia, SC 29209. USC Sumter has already established dual enrollment partnerships in Richland County. These programs have all been established at the invitation of high school officials and/or district superintendents.

Proposed course offerings at the site will comprise 25-49% of courses applicable towards an associate degree. Instructional methods employed for these courses will consist of traditional in-class, on-site, and online instruction, with USC-approved faculty members teaching the classes.

Population growth and demographic changes within the target population have led to a demonstrated demand for additional courses at the site. In order to meet its mission of serving these students, USC Sumter is seeking approval from the South Carolina Commission on Higher Education to offer courses for its associate degrees at Hammond School (located at 854 Galway Ln, Columbia, SC 29209).

#### **Assessment of Need**

Provide an assessment of the need for the program modification for the institution, the state, the region, and beyond, if applicable.

South Carolina adults are, by and large, undereducated. According to recent statistics, only 20% of South Carolinians between the ages of 25-34 earn a bachelor's, graduate, or other professional degree, which is below the national average. https://statisticalatlas.com/state/South-Carolina/Educational-Attainment

Richland County's overall population in 2020 was 416,147, and is expected to increase to 463,530 by 2035 (<a href="https://rfa.sc.gov/data-research/population-demographics/census-state-data-center/population-estimates-projections">https://rfa.sc.gov/data-research/population-demographics/census-state-data-center/population-estimates-projections</a>). Offering courses at the Hammond School site will enable USC Sumter to offer more options for high performing South Carolina students in a rapidly growing part of the state who are identified as eligible to enroll in dual enrollment coursework.

School administrators at Hammond School identified a need for dual enrollment course options and approached USC Sumter to offer these courses.

#### **Transfer and Articulation**

Currently, all USC Sumter's associate degrees are approved by the SC Commission on Higher Education and the Southern Association of Colleges & Schools Commission on Colleges (SACSCOC). The AA and AS programs are designed to transfer to a bachelor's degree and credits awarded towards these degrees are transferable to any institution which accepts transfer credit from the University of South Carolina.

### **Description of the Program**

This is a dual enrollment program offering students the opportunity to earn up to 24 credit hours over two years. There are currently no plans to offer the complete AA or AS degree at this site. The courses will be largely derived from the University of South Carolina's Carolina Core catalog (general education courses) and will be applicable to USC Sumter's Associate of Arts, Associate of Science, and USC Columbia's bachelor's degrees. USC Sumter was invited by Hammond School administration to begin offering USC courses at Hammond School, beginning Fall 2025. This program is governed by semesterlong contracts, which detail course offerings and financial support. This new location will enable USC Sumter to better serve students and to meet community needs in a growing area of the state.

This proposal does not seek to create any new degree programs but rather is designed to make existing associate degree programs available in a rapidly growing county within the USC Sumter service area. The AA and AS degrees are offered at each of USC's Palmetto College Campuses (Lancaster, Salkehatchie, Sumter, and Union).

Midlands Technical College offers similar dual enrollment opportunities in the Richland County area. USC Sumter has been invited by Hammond School officials to offer its courses as an additional choice for area students. USC Sumter's dual enrollment program is not anticipated or intended to replace Midlands Technical College's dual enrollment program and we are happy to collaborate with Midlands Technical College to offer coursework. Per conversations with the SC Technical College System, some Hammond School students enroll in dual enrollment coursework offered at the Midlands Technical College campus, but Midlands Technical College does not currently offer dual enrollment coursework at the Hammond School site.

No additional full-time faculty will be required to implement the program. Adjunct and affiliate faculty will be hired as needed. We plan to hire two to four new adjunct faculty depending on program needs. All adjunct and affiliate faculty will be approved by the home department of USC Columbia for their discipline. Each faculty member will be expected to meet minimum SACSCOC requirements for faculty appointments, namely an earned master's degree from a regionally accredited college or university, and a minimum of 18 graduate hours in the discipline being taught. All adjunct and affiliate faculty will be supervised by the Director of Faculty, Curricula, and Courses for Dual Enrollment Programs at the University of South Carolina Sumter. Academic policies, faculty expectations, and mentoring resources will be communicated to each faculty member through the Director of Faculty, Curricula, and Courses for Dual Enrollment Programs in consultation with the Executive Associate Dean for Academic and Student Affairs. All dual enrollment instructors are vetted through the usual USC credentialing procedures. Please note that faculty are called "affiliates" when they are paid by the high school and they are called "adjuncts" when they are paid by USC Sumter. However, the credentialing process for both types of faculty is identical and follows university policy and SACSCOC standards.

**Equipment:** Hammond School has allocated a sufficient number of classrooms to accommodate the USC Sumter courses. Each classroom is equipped with state-of-the-art technology to facilitate instruction with minimal to no additional equipment requirements from USC Sumter.

Being that the program is occupying an existing educational facility, all basic infrastructure needs are met. Although no major equipment purchases are anticipated to get the program off the ground, some items may be obtained to support individual disciplines as the program evolves. Such items might include laptop computers, printers, projectors, screens, document cameras, and consumable items such as dry erase markers, copy/printer paper, and other incidental office supplies. These purchases will be absorbed into existing campus budgets such as the IT budget and thus are not reflected in the budget provided. As enrollments and space requirements grow, unique needs such as supplies for art classes or science classes will be identified and added to the annual operating budget.

**Facilities:** No new facilities needed. Existing classroom and office spaces will continue to be utilized. Furniture and office supplies will be supplied by Hammond School.

### **Budget Justification**

Provide a brief explanation for all new costs and sources of financing identified in the Financial Support table.

All new costs of delivering this program to the new site will be funded through tuition revenue generated from new students attending at the location, as outlined above. USC Sumter will price these courses in line with the SC Lottery Tuition Assistance Program rates (currently \$75/credit hour). Any student wishing to take below the minimum of six hours required by LTAP will pay the tuition out of pocket. All students meeting the minimum LTAP enrollment requirement will have their tuition covered through financial aid. Expenses will consist primarily of faculty salaries for two to four new adjunct faculty. The model used for this proposal anticipates 70% of the faculty being adjuncts, compensated by USC Sumter at a rate of \$1,000.00 per credit/contact hour. Affiliate faculty are compensated by their home district and therefore incur no expense to USC Sumter.

As a Palmetto College campus, USC Sumter participates fully in the assessment endeavors of the University of South Carolina. There will be no new program offerings at Hammond School. However, all courses taught there will be subject to the same review and assessment procedures of those taught on campus.

All USC Sumter courses conduct student evaluations at the end of each semester. The results of these courses are compiled and shared with the faculty member and the Director of Faculty, Curricula, and Courses for Dual Enrollment Programs and the Executive Associate Dean for Academic and Student Affairs. These results are then used for annual peer and administrative evaluation of the faculty member.

Because the general AA and AS degree programs are awarded on all Palmetto College campuses, and because the degrees are comprised mostly of the University's Carolina Core, assessment is coordinated by the USC Columbia Office of the Provost and the Office of Institutional Research, Assessment, and Analytics. Palmetto College also has appointed a Director of Academic Program Assessment, who works closely with both entities listed above.

Each learning outcome of the Carolina Core is fully assessed at least once before the university's next SACSCOC accreditation visit. Artifacts (i.e., assignments which demonstrate a designated learning outcome) are collected from courses in the selected Core Outcome Group. Specialty team members from the campuses then review the artifacts and score them by using an assessment rubric. Results of the scoring are compiled and shared with faculty (or department/division chairs, as appropriate) for use in making modifications or improvements to the curriculum.

As the following chart indicates for the current cycle of assessments, the assessment of all outcomes is accomplished over a three-semester period based on departments:
