## **Transfer Mobility of Credits**

#### Keep in mind the following(ATCD):

- 1. Admissibility. Refers to the extent to which military experience credit courses determine a transfer student's admission to a university and, when applicable, admission to a specific program within a university.
- 2. Transferability and Degree Applicability-. Refers to the conditions under which a college/university accepts military experience credit courses for inclusion in the student's record.
  - THINGS TO WORK ON: Take a look at your military equivalences Work with colleges to consider more direct subject matter equivalencies
- 3. **C**ourse Equivalency and Transferability: Refers to the process of equating a transfer student's military experience credit courses, both in hours and content, to a university's coursework.
  - THINGS TO WORK ON: Take a look at transfer equivalences your institution has already established for military credit within current articulation agreements (if any)
- **4.** <u>Degree Applicability</u>: Applicability of credit toward a degree refers to the prerogative of an academic authority to count specific military experience credit courses toward the fulfillment of a student's degree requirements
